

INFORMATION ART. 13 EU REGULATION 2016/679 (GDPR)

In thanking you for providing us with your personal data, we inform you of the purposes and methods of the processing for which they are intended.

Data Controller

Purpose of the processing

The purposes of the processing will be:

- a) The management of pre-contractual and contractual relationships and activities concerning the fulfilment of the obligations contained in the contract for the supply of goods or services (art. 6. b)
- b) The management of any disputes (art. 6 lett. f)
- c) Communications between the parties, in the context of the provision of the service/product (art. 6. b)
- d) Fulfilment of accounting and tax obligations (Article 6 letter c)

Mandatory nature

All the data requested, even if personal, are mandatory as they are necessary for the management of the contractual relationship. They are based on the need to perform the contract and comply with legal obligations, therefore, your consent to the processing is not required.

Failure to provide the data necessary to fulfil the above purposes will make it impossible for the Company to manage the contractual relationship with you.

Recipients of personal data

Personal data may be communicated:

- To the company's staff as data processors for the management of the practices relating to the contract put in place; Staff have been duly trained in the security of personal data and the right to privacy
- To credit institutions for payment collection operations
- To the accountant and/or similar freelancers for the correct execution of legal tax obligations
- To the state bodies responsible for checks and controls on the regularity of the accounting and tax obligations required by law
- To the subjects who are entrusted with the maintenance and development service of our IT system for the time strictly necessary for the execution of this service
- The list of these subjects is constantly updated and is available at the company's headquarters, upon its request
- In any case, it is forbidden to communicate or disseminate your personal data to subjects who are not necessary for the performance of the services you have requested

Data transfer abroad

The data you provide will not be transferred to a third country or to international organisations.

Data retention period

The data provided will be stored for the entire duration of the current commercial relationship with the Company and, subsequently, for the period of time provided for by the legislation, applicable to the aforementioned relationship; At the end of this period, your data will be deleted or made anonymous. In particular, your personal data will be stored for a maximum period of 10 years in compliance with Article 2220 of the Civil Code and Article 22 of Presidential Decree No. 600 of 29 September 1973.

Processing methods

The data will be processed mainly with electronic and IT tools, stored both on computer supports and on paper and on any other type of suitable support, in compliance with the minimum security measures pursuant to art. 32 of EU Regulation 2016/679.

Obligations towards the data subject

We have an obligation to respond to your requests regarding how and why we process your data; the obligation to rectify incorrect data, integrate incomplete data and update data that is no longer accurate; the obligation to erase data and to restrict processing; the obligation to transmit your data to you or to third parties indicated by you; the obligation to stop processing if you no longer agree.
